Re: change of management company

Natixis Investment Managers is transforming its European management and distribution activities.

In order to optimise how its multi-affiliate model works and to strengthen its sales efficiency by bringing added value to its customers and distributors, Natixis Investment Managers has introduced a transformation project for its European management and distribution activities.

On 1 October 2018¹, the following activities will be brought together within the Natixis Investment Managers International management company:

- distribution of Natixis Investment Managers' asset management offering in France;
- the management company's role as head of open-ended funds financially managed by Ostrum Asset Management, Mirova and Seeyond. It will be managed by the administrative and support functions dedicated to the affiliates and sales forces;
- the Solutions platform, designed to propose innovative and high value-added management offers, which are based in particular on the expertise of 27 affiliates of the group.

For customers, distributors, investors:

- Natixis Investment Managers International will inherit the current legal structure of Ostrum Asset Management (formerly Natixis Asset Management);
- The management teams and management processes will remain unchanged.

Regarding the Mirova Actions Monde*, Mirova Actions Euro*, Mirova Obli Euro*, Mirova Actions Europe*, Mirova Europe Environnement*, Mirova Emplois France*, Mirova Euro Sustainable Bond Fund and Insertion Emplois Dynamique* mutual investment funds, **Natixis Investment Managers International (formerly Natixis Asset Management) will replace MIROVA as the management company from 1 October 2018.**
